**WHEREAS**, on February 11, 2020, the Procuring Entity published an Invitation to Bid for the Procurement of ICT Equipment for the Philippine National Police Legal Service (PNP LS) under Public Bidding No. PNPTR-LS-DP-20-02, with an Approved Budget for the Contract of Two Million Pesos (Php2,000,000.00);

**WHEREAS**, on February 20, 2020, the Information Technology Management Service (ITMS) Bids and Awards Committee (BAC) and its Technical Working Group (TWG) conducted a Pre-bid Conference;

**WHEREAS**, on February 24, 2020 as a result of the Pre-bid Conference, the ITMS BAC issued a Supplemental/Bid Bulletin to modify and amend some provisions of the Technical Specifications on the Bidding Documents;

**WHEREAS**, the Submission and Opening of Bids for the Procurement of ICT Equipment for the PNP LS was scheduled on March 3, 2020, 9:30 AM;

**WHEREAS**, in response to the said invitation, below are the proponents who purchased and dropped their bid documents before the deadline of submission of bids as well as the result of the bid opening using a non-discretionary pass or fail criterion:






