**DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID**

**WHEREAS**, on December 4, 2020, the Procuring Entity published an Invitation to Bid for the Procurement of One (1) Lot Information and Communications Technology Equipment (ICT) for PRO 1, PRO 3, and PRO 4B under Public Bidding No. PNPTR-DIDM-DP-20-11 with an Approved Budget for the Contract of Nine Million Nine Hundred Eight Thousand Pesos only (PHP 9,908,000.00);

**WHEREAS**, on December 11, 2020, the Information Technology Management Service (ITMS) Bids and Awards Committee (BAC) and Technical Working Group (TWG) conducted a Pre-bid Conference;

**WHEREAS**, the Submission and Opening of Bids was scheduled on December 23, 2020 at 9:30 AM;

**WHEREAS**, in response to the said invitation, Maxcor Inter-Ventures Co. purchased and dropped their bid documents before the deadline of submission of bids;

**WHEREAS**, as a result of the bid opening using a non-discretionary pass or fail criterion Maxcor Inter-Ventures Co. was declared as **ELIGIBLE** and **SINGLE CALCULATED BIDDER** with bid price of **Nine Million Nine Hundred Two Thousand One Hundred Ninety Pesos (Php9,902,190.00)**;

**WHEREAS**, the TWG conducted post-qualification proceedings on the bid of Maxcor Inter-Ventures Co. from December 23, 2020 to January 4, 2021 to verify, validate and ascertain all statements made and documents submitted by the said bidder;

**WHEREAS**, after careful deliberation of the Post-Qualification Report submitted by the ITMS BAC TWG for the Procurement of One (1) Lot ICT Equipment for PRO 1, PRO 3, and PRO 4B on January 18, 2021, the ITMS BAC found that all the legal, technical and financial requirements submitted by Maxcor Inter-Ventures Co. are responsive to the requirements of the Bidding Documents;


