INVITATION TO BID FOR THE

“Procurement of one (1) Lot ICT Equipment for DICTM Annex”

1. The **Philippine National Police-Information Technology Management Service (PNP ITMS)**, through the **PNP Trust Receipt for the Month of October 2020** intends to apply the sum of **One Million Three Hundred Forty-Six Thousand Seven Hundred Pesos only (PHP 1,346,700.00)**, being the ABC to payments under the contract for Public Bidding No. **PNPTR-DP-DICTMANNEX-2021-02**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **PNP ITMS** now invites bids for the above Procurement Project. Delivery of the Goods is required within **forty-five (45) calendar days** from receipt of notice to proceed. Bidders should have completed within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information **PNP ITMS** and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM during working days.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 29, 2021 to April 19, 2021** from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PHP5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees ***in person***.

6. The **PNP ITMS** will hold a Pre-Bid Conference on **April 5, 2021, 9:30AM** at the **PNP ITMS Conference Room, PNP ITMS, Camp BGen Rafael T Crame, Quezon City** and/or through video conferencing or webcasting **via Zoom Video Communications**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission at the office address indicated below**, on or before **April 19, 2021, 9:30AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **April 19, 2021, 9:30AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **PNP ITMS** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


