INVITATION TO BID FOR

- 1. The Philippine National Police-Information Technology Management Service (PNP ITMS), through PNP Trust Receipts for 4th Quarter CY 2015, intends to apply the sum of Fifty-Six Million Pesos (Php56,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Development and Implementation of PNP Human Resource Management Information System (HRMIS): Procurement of I.T. Equipment and Software for PNP HRMIS under PUBLIC BIDDING NO: TR-04-15-19-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *PNP ITMS* now invites bids for the aforementioned project. Delivery of the Goods is required within **three hundred sixty (360) calendar days** from receipt of notice to proceed to winning bidder. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from *PNP ITMS* and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM during working days.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 22, 2019 to December 11, 2019* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIFTY THOUSAND PESOS (Php50,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- The PNP ITMS will hold a Pre-Bid Conference on November 29, 2019 at 9:30 AM at 6. the PNP ITMS Conference Room, Camp BGen Rafael T Crame, Quezon City, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before 7. December 11, 2019 at 1:00 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 11, 2019 at 1:00 PM at the PNP ITMS Conference Room, Camp BGen Rafael T Crame, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- The PNP ITMS reserves the right to reject any and all bids, declare a failure of bidding, 8. or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
